ORDER

With a view to generating e-permit for agri-commodity trade & its allied activities it is felt necessary to provide a comprehensive list of agri-commodities showing the percentage of market levy charged at present against each of the items which have been existing in the schedule of the W.B. Agricultural Produce Marketing (Regulation) (Amendment) Act, 2017 and later included in the said schedule vide notification No. 877-AM/O/9M-46/2011 dt. 24/07/2017 and No. 924-AM/O/9M-46/2011 dt. 05/08/2019 and those agri-commodities which have been exempted from the charging levy in exercise of the power conferred by Section 29 of the West Bengal Agricultural Produce Marketing Regulation Act, 1972 vide this Department's Notification No. 925-AM/O/9M-46/2011 dt. 05/08/2019.
